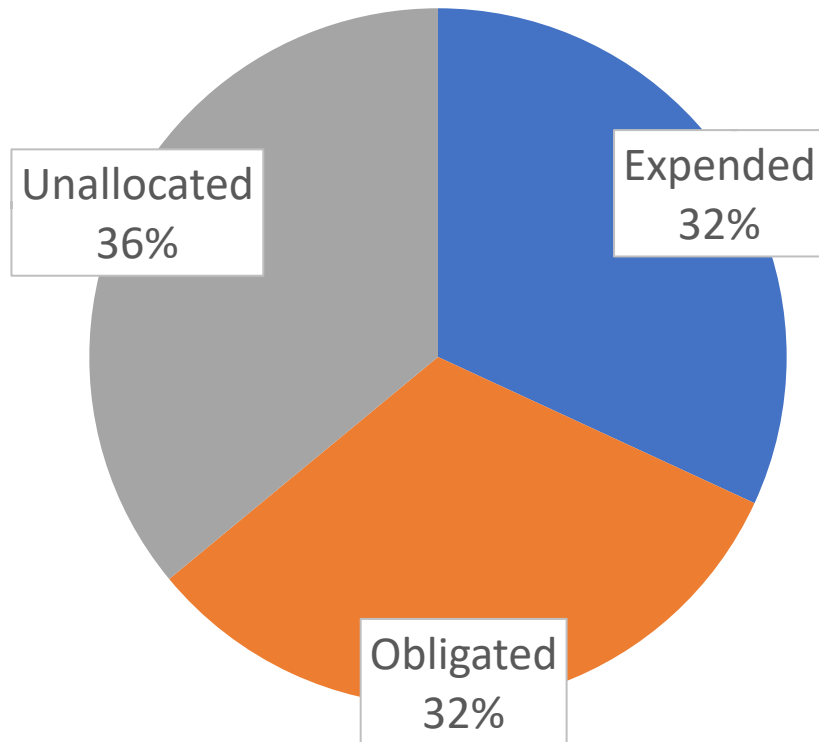
ARPA SLFRF- Background

- Signed into law by President Biden on March 11, 2021
- Includes \$65.1 billion for Counties nationwide, \$1.5 Billion for Washington State
- Counties began receiving 1st tranche in May 2021, second tranche in May of 2022
- Funds must be allocated by 2024, spent by 2026

ARPA SLFRF- Eligible Uses

- Responding to the COVID-19 pandemic
- Covering costs incurred from the public health emergency
- Replacing lost or decreased revenues due to COVID-19
- Addressing the negative economic impacts on local businesses and nonprofits
- Making necessary investments in water, sewer, and broadband infrastructure

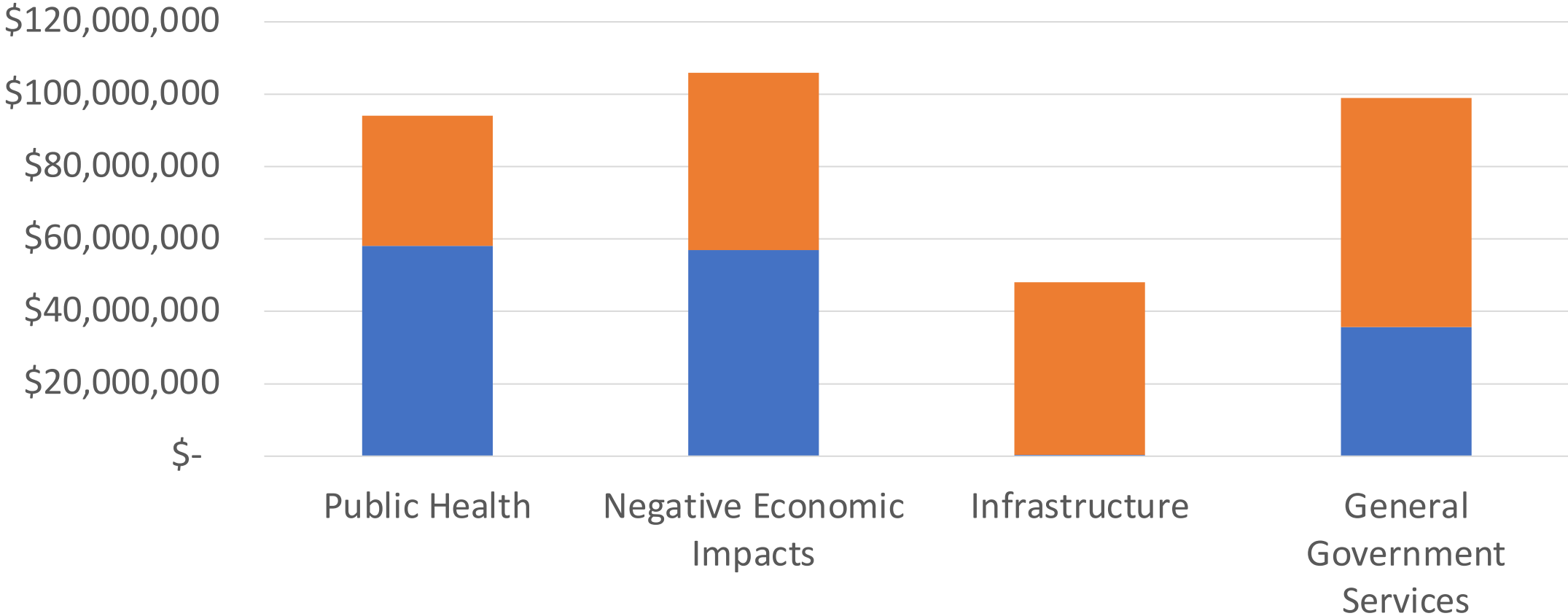
ARPA SLFRF- First Year Trends



Spending and budgeting through April 1st, 2022

- 32% of total funding spent, \$151 Million, despite not receiving 2nd tranche of funding before the last data update
- 32% of total funding is dedicated to a specific project
- Must allocate all funds by 2024
